

Searching the EDGAR Database

Lexis

In Lexis Advance, enter EDGAR in the search box.

When the popup appears, select SEC EDGAR Filings, Combined

You are now in the database and can enter your search term. In the example attached, I searched for “security agreement” /p “good faith” to see if the parties had defined good faith in their security agreement.

I then narrowed the search by date, using the Timeline filter on the left.

Finally, I entered “Exhibit 10” under Search Within Results on the left. This limited the search to the Material Contracts that are part of Exhibit 10 of a filing. This gave me 170 results, which I was then able to search.

Bloomberg

In Bloomberg Law, select EDGAR from the Research menu under GETTING STARTED

You are now in the EDGAR database.

If you then click on Exhibits, you will get a popup menu and can select Ex-10. Material contracts.

On that same page, under Keywords, enter your search term such as “security agreement” /p “good faith”

You can also narrow the search by Filing Date.

This gave me 211 results, which I was then able to search.

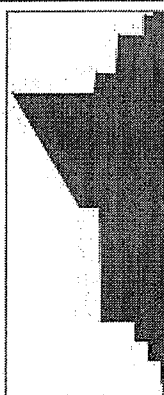
